<b>6.3 Direction (clockwise or anti-clockwise)</b> Clockwise
<b>6.4 Location of pit exit in relation to Line</b> The Pit Exit is 580m after the Line on the right hand side, 80m before Turn 1.
<b>6.5 Location of position Pole position</b> - Standing start – Left Side - Rolling Start – Right Side
