ADDENDUM – Peugeot Rally Cup Ibéria 2018

Valid for Competitors registered in the Peugeot Rally Cup Iberia 2018



Addendum to Visa ASN n° 074/WRC/2018 issued on 16/03/2018

Art. 1 - GENERAL

1.1 - For all purposes, the participation in Vodafone Rally de Portugal - Peugeot Rally Cup Iberia 2018 of the registered competitors, is regulated by the Supplementary Regulations of the race, published in www.fpak.pt.

1.2 - The purpose of this Addendum is to regulate the classification of riders participating in the Vodafone Rally of Portugal - Peugeot Rally Cup Iberia 2018, registered in the Peugeot Rally Cup Iberia, for the purpose of scoring in the same.

Art. 3 - VEHICLES ADMITTED

3.1 - All vehicles that comply with the Technical Regulation of the Peugeot Rally Cup Iberica 2018 and with the Art. 253 and 260 of Annex J to the CDI

Art. 4 - RECONNAISSANCE Peugeot Rally Cup Iberian

4.1 - In accordance with Article 9 of the Supplementary Regulations of the event.

Art. 5 - DEVELOPMENT OF THE PROOF

5.1 - The Vodafone Rally of Portugal - Peugeot Rally Cup Iberia 2018 is played in 9 PECs in a total of 152.02 Km, ending in the Time Control TC 9A (according to the particular regulation of the race).

5.2 - The order of departure of the Peugeot Rally Cup Iberian is established by the classification in Shakedown

Art. 6 - TYRES

6.1 - In accordance with Article 7 of the Supplementary Regulations of the race and Art. 8.2 of the Peugeot Rally Cup Iberian Technical Regulation

Art. 7 - FUEL

7.1 - In accordance with Article 8 of the Supplementary Regulations of the race and Art. 4.3 of the Peugeot Rally Cup Iberian Technical Regulation.

Art. 8 - CLASSIFICATION

8.1 - For the purpose of scoring for the Peugeot Rally Cup Iberia, it is considered the end of the race in the Time Control TC 9A, being established there the final classification of the Vodafone Rally of Portugal - Peugeot Rally Cup Iberian. Only the riders registered in the Peugeot Rally Cup Iberica 2018 will be considered classified.

8.1.1 - Any team wishing to complete their race must hand in their control letter to the Commissioner of the Time Control TC 9A, thus assuming their intention to abandon Vodafone Rally de Portugal 2018.

The vehicle will then be sent to the Closed Park and where, depending on its classification, it will be subject to a final technical verification.

8.1.2 - Any competitor may remain in evidence after TC9A time control.

In this case you will have to sign a compromise document, which in case of subsequent withdrawal, is obliged to:

a) Immediately inform the Technical Scrutineer - Peugeot Rally Cup Iberica

b) The competitor will have the responsibility to place the competition car in closed park at the end of the day in which the withdrawal occurs and until the opening of the same.

NOTE: Failure to comply with this article implies disqualification of the final classification of Vodafone Rally de Portugal - Peugeot Rally Cup Iberia 2018.

c) The specific commitment document of the PRCI shall be signed by the competitor, after leaving TC 9 A control zone, with the representative of PRCI

Art. 9 - PUBLICATION OF CLASSIFICATIONS

9.1 - An informative classification (extracted from the different classifications) will be elaborated after the Time Control TC 9A and the Final Technical Verification (PRCI) that will be realized immediately after a place to designate in the Assistance Park

9.2 - The PRCI Provisional classification will be published about one hour after the publication of the official Vodafone Rally of Portugal PRCI 2018 (scheduled for May 20, 2018);

9.3 - The official PRCI Official Final classification will be published, 30 minutes after the publication of the provisional classification of Vodafone Rally de Portugal - PRCI 2018

Art. 10 - FINAL CHECKS

10.1 - Once the informative classification has been published, in case of withdrawal after TC 9A Timekeeping.

10.2 - After being sent to closed park, in case of continuity in proof after Time Control TC 9A and later withdrawal.

10.3 - Immediately after the opening of the final closed park, in case of completing the entire Vodafone Rally de Portugal - PRCI 2018.

Art. 11 - AWARDS / PREMIUM DISTRIBUTION

11.1 - Peugeot Rally Cup Iberia Awards

The following trophies will be delivered

a) 1st, 2nd and 3rd General General Classification

b) 1st Junior Rank

c) 1st Place Women's Team

The 2nd drivers / navigators will be awarded trophies identical to the 1st drivers.

11.2 - Distribution of Prizes

The prizes are awarded to competitors at the following event: Castelo Branco Rally
